- It is not possible to apply for housing allowance.
- The deposit is € 970.00.
- Occupancy is possible for a maximum of 1 person (no couples allowed).
- The minimum rental period is 12 months.
- Smoking in the house is not allowed.
- Pets are not allowed.
- This house is suitable for students.

Income requirement for working people:

- Gross income of 3.5 times the rent. Savings may be added to the gross monthly income by 1%.
- For employees: a remaining term of employment contract of at least 10 months or a declaration of intent for extension.
- For self-employed persons: a confirmation of the income by an external accountant for the entire past financial year and the current financial year (forecast).
- In other cases, a guarantor or an increased deposit may be eligible.



Income requirement students:

- Students may qualify with a guarantor or an increased deposit.

Guarantor income requirement:

- Living or working in the Netherlands.
- Sufficient income and/or assets to meet the rental obligations under the guarantee in addition to your own expenses.
- The same requirements as for employees or self-employed persons.

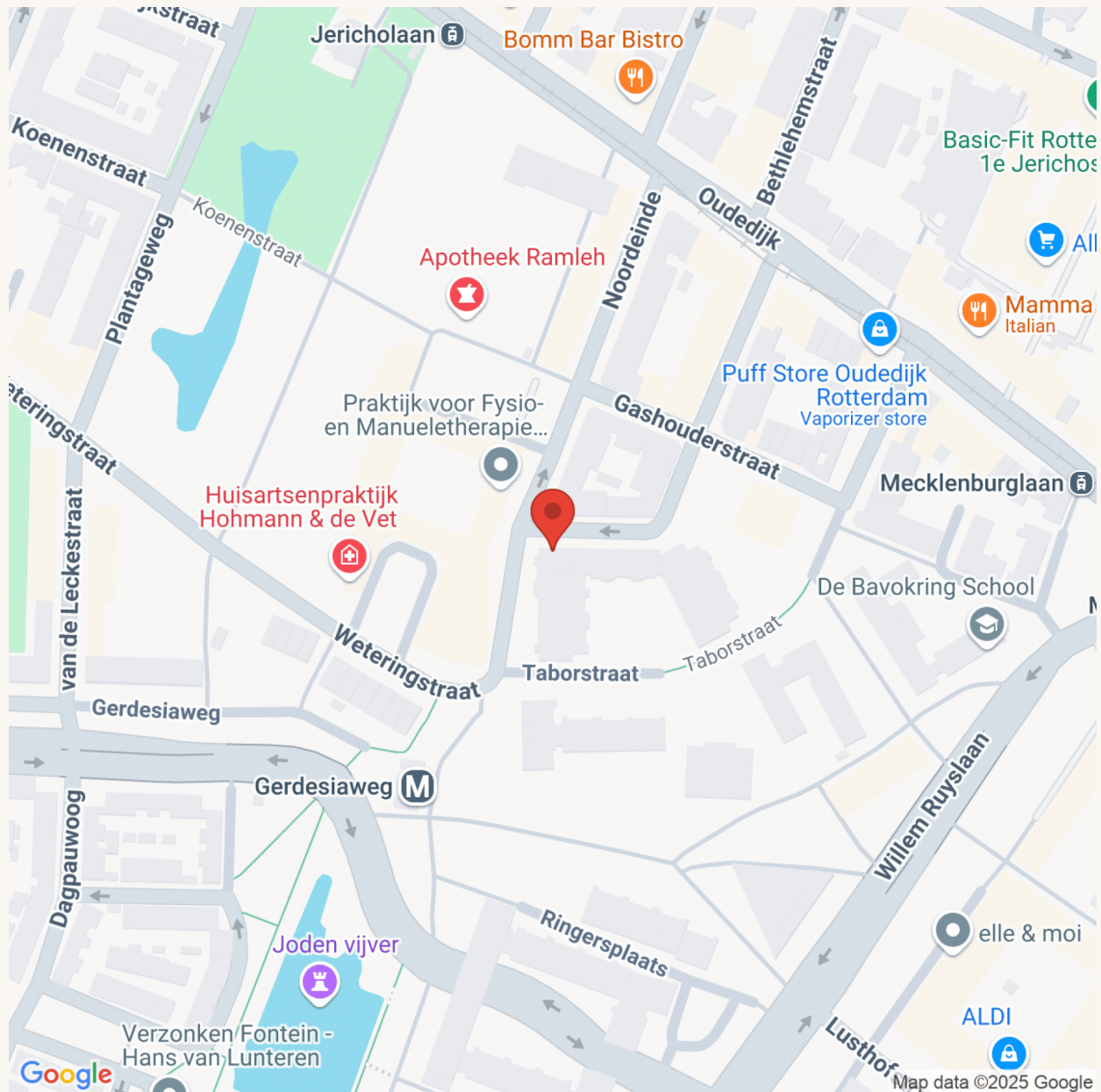
